- 1. Welcome and Announcements: Marie Bourgeois welcomed the General Education Council (GEC) membership and guests to the meeting. Quorum was established promptly at 3:00 p.m. (EST).
- 2. Approval of October 16, 2023 General Education Council Meeting Minutes The minutes were approved as submitted.
- 3. Informational Items
 - A. Senate Bill 266 Kyna Betancourt provided a brief summary of the State Senate bill and the revising of duties relating to the mission of each university. Kyna's presentation focused on how general education (GE) courses are established with examples such as Intro to Oceanography now being in the core but likely removed from High Impact Practice GE due to needing to ensure that students receive their full thirty-six hours. The largest change will come in Social Sciences where Am. History I and II were added, however civic literacy competencies which are state required are minimally covered by the curriculum found in Am. History II. Also, Intro to Sociology is now struck from the Gen Ed core. The current goal will be to move Intro to Sociology for Fall 2024 into Enhanced General Education. Kyna noted an unexpected positive effect of the change could come with more students being exposed to Principles of Sociology as it can be applied as a component to their Enhanced General Education.

- B. New BOG Regulation 8.005 Kyna Betancourt provided a summary of how institutions will begin reporting all of their general education course offerings. General Education courses will first be approved by the institution's president, then by the institutions Board of Trustees and then finally to the Articulation Coordinating Committee that reports to the Board of Governors. If an approved list is not generated, the institution could face modifications to their funding. Course descriptions and learning outcomes are currently not required to be included in data sent through the above institutional hierarchy. Kyna provided a brief recommendation about how institutional leadership would be likely be the best source for deciding what General Education courses are on the list as the presidents of each institution and Board of Trustees will be held accountable for the lists they forward. To close, Kyna provided a timeline starting with the Committee on Academics meeting on May 21, 2024 and then the full board meeting on June 4, 2024 which will likely be the last meeting that a vote can occur for the changes to go into effect by Fall 24. The Articulation Coordinating Committee will need the approved list by September 1, 2024, and they have to submit it to the Board of Governors by December 1, 2024.
- C. **Mathematics Pathways** Kyna Betancourt noted that the new legislation will require all programs to indicate which of the three mathematics pathways they will require for students as they enter their programs. One pathway will be Algebra to Calculus. The second pathway is Statistics, and the third pathway will be Mathematical Thinking in Context. Based on this curriculum structure, most changes will be minimal and will primarily occur in the packaging and marketing to students.
- D. GEC Staff Support Change (Spring 2024) Kyna Betancourt notified the council members that Undergraduate Studies support staff will steadily change over the next few weeks. Support for council proposals and minutes will move back to Lorene Hall Jennings and her new support staff hire. David Hicks will be moving to other responsibilities within Undergraduate Studies. Lorene's new staff will continue training this semester on an interim basis with the goal of supporting the council full-time in the Fall. - E. **Two HIP Attributes for Tier 4 Courses** Kyna Betancourt noted there was an inquiry about whether one course could feature two HIP attributes. Kyna noted that it is possible, however, courses have not historically been structured this way. Marie Bourgeois and other council members were curious about whether faculty would have enough time to properly address both attributes in the curriculum. Kyna noted examples of courses studying abroad as an instance where two HIPs could be included without drastic changes being necessary to curriculum as students would be simultaneously experiencing the curriculum in

real life situations while also learning from the current instruction. Ultimately, a vote was cast and unanimously approved.

F. **INT - 4942 - Internship in Deaf Studies (attribute discontinue) -** Marie Bourgeois provided a summary of the discontinuation and noted that this will be a full course discontinue and not just an attribute discontinue proposal. This was confirmed by Jennifer Lister.
