I. <u>Call to Order and Comments</u>

Chair Jonathan Ellen called the meeting to order at 8:30 am.

II. <u>New Business – Action Items</u>

a. Approval of May 30, 2018 Meeting Notes

Motion to approve the Meeting Notes from May 30, 2018. Notes approved unanimously.

III. <u>New Business – Information Items</u>

Chair Ellen noted that the goal is to start synthesizing and summarizing information from subcommittees.

a. Subcommittee Updates

Anddrikk Frazier provided an overview of the first Student Access Subcommittee hearing, nothing the goal was to understand the student process from pre-application to graduation. Both internal and external experts presented information regarding the various aspects of this process. Without reviewing specific slides as presented, Mr. Frazier highlighted a few takeaways from the hearing. He stated the USF System has many existing successful programs, however we need to find ways to broaden access to those programs. Additionally, Mr. Fraizer noted another takeaway was telling our story and making sure that it is disseminated throughout our communities especially within the high school systems. The final takeaway was the availability of courses throughout the USF System to enhance access to academics.

Mike Griffin noted that the Student Success/Academic Programs/Campus Identity Subcommittee's first hearing is July 9 in Tampa. The members have been working to develop building blocks to understand the SACS Accreditation processes and requirements, particulary around new degree programs and changes in degree programs. The Florida BOG will present their regulations regarding academic programs. Academic officer representation from each campus will add to the overall conversation regarding internal processes. Future hearings will delve further into labor and workforce issues and other related issues.

Melissa Seixas shared that the Shared Governance/Transparency Committee held a meeting via phone on June 14th to discuss the upcoming hearing. Ms. Seixas was able to attend the first Access Subcommittee hearing, which was helpful as to how to structure subcommittee meetings moving forward. The subcommittee has worked on building that framework for the first hearing on July 18th, with a focus on regulatory issues. The Florida BOG, SACS and USF System General Counsel will present that framework around fees, general education, student governance

and shared services. She noted that there was discussion regarding one-page takeaways to be used by members for later reference.

b. Internal Implementation Committee Update

Chair Ellen introduced Peter Stokes with Huron Consulting Group to provide an overview of the internal implementation work. Mr. Stokes explained the difference between the various groups working to support consolidation. At a very high level, the Task Froce has been charged with creating a set of recommendations in some broader areas about achieving a desired outcome while maintaining accreditation and preeminence. The BOT Consolidation, Accrediation and Preemeience (CAP) Committee is focused on how to implement all of these aspects involved in moving to reach consolidation. The Task Force is focused on considering external perspectives while the CAP is focused on internal voices and the more detailed aspects of implementation. The CAP is also considering some broader issues that are not within the focus of the Task Force charge.

As an example, using Mr. Frazier's presentation, a high level recommendation could be "to increase flexibility in course programming in location and time to enhance student access." The CAP might use that to develop the plan to enhance insitutional capacity to match demand and increase access and then implement that plan. Huron will be supporting the parallel processes and will determine if there are opportunities for alignment and information sharing.

Huron will assist with consistent introductory talking points for hearings as well as helping to shape questions that should be addressed at hearings. Mr. Stokes is expecting to hear initial baseline work at first hearings with more in-depth information gathering as the subcommittees move forward.

c. Data Requests and Questions

Chair Ellen reminded everyone to to reach out to staff liaisons for information or with any questions.

Chair Ellen noted that public comment area on the website has been updated to be more accessible to the public.

Hearing Summary

The process to create new degree programs in the State of Florida can be lengthy and complex.

- To respond to the needs of the local and campus communities, research feasibility of:
- offering new majors, minors and certificates; and
- expand educational opportunities in existing degree program areas throughout the USF System.

Hearing Summary Cont.

- Online education can allow students to stay at their home campus while having access to required courses available at other physical locations online. Consolidation provides opportunities for expansion including master courses, hybrid programs and shared resources among all USF campuses.
- Student success, the connection to the community, and life long learning is the foundation for the Subcommittee's work. Future work will include looking closer at financial resources, adequately serving all communities, tailored planning for each USF campus and preserving unique identities.

Potential Recommendations

- Add a student representative to the USF System Academic Program Advisory Committee.
- Enhance efforts to obtain community and industry input when developing new degree programs, majors, minors and certificates.
- Expand and deliver additional online classes.
- Increase blended learning and hybrid course offerings.
- Develop online master courses to be used across campuses.

Student Access Subcommittee Hearing 1 Takeaways

Barriers to access include:

- Financial
- Academic preparedness
- Access to information
- Life responsibilities

Student Access Subcommittee Hearing 1 Recommendations

- Enhance information dissemination regarding financial aid
- Ensure flexibility in course programming (both online and in-person)
- Leverage community partners
- Explore use of technology to provide flexibility in course programming, and to improve access to information and college readiness.
- Start early (before high school) informing and motivating students about higher ed options.

Student Access Subcommittee Hearing 2 Takeaways

- Consolidation may affect admissions rates(though with minimal effect on black/Hispanic percentages) in AY 19/20, but will be mitigated through emphasis on alternative terms of entry and partnerships with local state colleges.
- Measuring diversity is challenging; if outreach continues to focus on diverse populations, diversity will organically increase.
- Best practices for student access target FAFSA completion rates, which are low for low-income and first generation students.

Student Access Subcommittee Hearing 2 Takeaways

- Virtual solutions and increased delivery of online courses can help with access across all three USF campuses.
- Additional support and early engagement leads to greater success, especially for first generation university students.

Student Access Subcommittee Hearing 2 Potential Recommendations

- Continue and strengthen strategic partnerships with:
 - Schools, school districts and community colleges.
 - Local high schools to increase awareness on admission deadline dates, admissions criteria and financial aid information.
 - Local College Access Networks who use best practices.
- Expand admissions pathways with local high schools for guaranteed admissions.
- Develop outreach offices at USF St. Petersburg and USF Sarasota-Manatee.

Student Access Subcommittee Hearing 2 Potential Recommendations

- Explore multiple summer bridge programs including focus on STEM, career specific programs and internships.
- Continue to identify creative sources of financial assistance that will attract students from underserved populations.
- Foster education ecosystems (i.e. data sharing with local schools, school districts and community colleges on factors beginning in pre-K that impact student performance that can inform interventions).
- Consider online technology to create virtual classrooms across campuses.
- Strengthen hiring practices to include bilingual and bicultural staff.

Student Access Subcommittee Hearing 2 Potential Recommendations

- Create special FUSE programs focused on specific demographics, i.e. Latinos.
- Develop specific "college" nights for underserved populations and their families.
- Expand campus visits to start early on in a student's educational journey.
- Expand "last dollar" scholarship offerings.
- Support and increase awareness around Florida College Access Network's Seminars.
- Offer classes that teach English as a second language.

The State of Florida's higher education regulatory process is complex, but creates a system of well vetted academics, accountability in structure and transparency in process.


Hearing Summary Cont.

- The USF System has many **shared resources**, including general counsel, controller, human resources and others. Some services can not be shared due to SACS requirements for separately accredited institutions. With an accreditation consolidation, more resources could move to a centralized function while others will need to remain present on each campus.
- The USF System has 3 **student government associations** with separate budgets as determined by current regulations.
- The Subcommittee's future work includes a closer look at shared resources, fee structures, student and faculty governance structures and general education process.

Potential Recommendations

- Structure that allows for 3 student governments in an effective way including system-wide representation.
- Shared services that can be more centralized after consolidation but that allow for accessibility and integration across campuses.

Summary of relevant SACSCOC Requirements

SACSCOC Requirements			
Α	None of the campuses can have a separate, unique mission statement. However, USF's BOT may want to create one new mission statement for the consolidated institution that specifies the uniqueness of each campus.		
В	Authority resides in the University of South Florida's Board of Trustees. Campus Boards can be advisory only.		
С	There must be one general education program for the new USF institution.		
D	The consolidated institution will develop one Quality Enhancement Plan (QEP) for Reaffirmation of Accreditation in 2025.		
E	There can only be one College of the same field of study (e.g. Business, Education, Engineering). It could be possible to have two differently designated Colleges that offer curricula in "business" disciplines, but the colleges would need to be differentiated, such as a College of Business and a College of Entrepreneurship.		
F	Programs must roll up to a single College with a clear administrative structure and reporting lines.		
G	Curricula for the same degree (e.g. BS in Accounting) must be the same on each campus.		
Н	Cannot have different programs of study or have different student learning outcomes for the same major (e.g. BS in Accounting) on each campus, but each campus can offer its own unique concentrations within a major.		
I	The student learning outcomes for the same major and same degree are expected to be the same.
