The televised conferences, for example, featured participation by Governor Lawton Chiles, more than 20 judges, including the Chief Judge of the 13<sup>th</sup> Judicial Circuit (Hillsborough County) and the Chief Justice of the Florida Supreme Court, the State Attorney and the Public Defender in Hillsborough County, State Senators, the SWAT team, and many highly-respected prosecutors, defense lawyers, private attorneys, law enforcement officers, and social services and juvenile justice personnel. Introductions of the distinguished guests were often done by USF Presidents, including Frank Borkowski, Betty Castor, and Judy Genshaft.
