### **FUNDING**

Once ALL the required documents are received to establish the **Proposal Enhancement Grant** award, an email will be sent to the PI when the funds are available for use. These funds must be kept in a separate Research Initiative Account (RIA) with the fund number **18326 for the Proposal Enhancement Grant**.

These funds must only be used for the allowable expenses described in the approved proposal budget and **cannot be co-mingled with other research funds**. Any unallowable expenditure/s on the award will be subject to removal off the grant to an unrestricted account.

**Any** re-budgeting must be requested and approved. Submit re-budgeting requests, using the form from the [Internal Awards Program website](#) to [rsch-internal-awards-program@usf.edu](mailto:rsch-internal-awards-program@usf.edu)

Any unspent funds will be swept back to USFRI at the end of the grant period. The 12 months grant period is provided in the award notification email.

### **DISSEMINATION OF PROJECT RESULTS**

The Principal Investigator is expected to publish or otherwise make publicly available works resulting from this grant. All publications resulting from this grant must include the following acknowledgment: "This work was supported, in part, by the University of South Florida Research & Innovation Internal Awards Program under Grant No. \_\_\_\_\_." Please use the PI's seven (7) digit Research Initiative number as your grant number (i.e., 0012345).

## **PAPERWORK REQUIRED TO OPEN YOUR AWARD**

Submit paperwork electronically to [rsch-internal-awards-program@usf.edu](mailto:rsch-internal-awards-program@usf.edu) at Once all paperwork is received and processed, an email notification will be sent to the PI that the account is open for spending.

Please be aware that other post-award activities (e.g., purchasing, payroll, travel, access to the FAST financial system) are managed by other departments within the university and you will need to work with these units directly.

1. **PI must** have a **Research Initiative Account (RIA)** (Chartfield 00 “account”). **If the PI does not have one**, establish a new account by completing a [“Request to Establish a Chartfield”](#) form (see instructions below). Send the form to **James R. Nally, Accounting Services (Controller’s Office), 813-974-6041, and Email: [rnally@usf.edu](mailto:rnally@usf.edu)**. This is the “account” from which the funds can be spent for items identified in the approved proposal budget. These funds may not be co-mingled with other funds (e.g., your department RIA or another department or PI’s RIA) and may not be used for other projects or purposes.
2. **PI must** submit the [Internal Form](#); see instructions below for help to complete.
3. **PI must** submit a signed [Grant Budget Release](#) form; located on the [Sponsored Research Forms](#) page. See instructions below for help to complete. This will be checked against the approved proposal budget.
4. If the study involves human subjects, animals or biohazards, the **PI must submit, as part of their required paperwork,** copies of **approvals confirming compliance (see compliance** Funds will not be released until these documents have been received.
5. After the RIA has been confirmed (or set up) and the PI has the chartfield string (“account” #), **PI must** submit to FAST Security a [FAST Workflow Request Form](#) to establish who has spending authority and signature authorization for these funds. The completed form must be sent to [BUSFIN FAST Security](#).
6. If you want to be able to view your account activities in the **FAST financial system**, you must have official access to the FAST system. If you do not yet have access to FAST you must fill out and submit the [FAST Workflow Request Form](#) (see instructions on the [Controller’s website](#)).
7. If travel has been approved in the budget for this project, the PI must follow guidelines established by the [Travel Department to submit the travel request](#). The RIA chartfield for the PEG is to be used as the chartfield for the travel.

### How to complete the [Grant Budget Release Form](#) (located on the Sponsored Research website)

1. Expenses must conform to the items identified in the approved proposal budget/if budget was reduced adjust accordingly.
2. Use the following chartfield string to fill out the form:

**Oper Unit** = TPA (Tampa except HSC), HSC (Health Sciences Center), STP (St. Petersburg), SAR (Sarasota/Manatee)  
**Fund** = 18326 (The Fund Code is the number in the Chartfield String that distinguishes this initiative from your other research initiatives)  
**Dept. ID** = your 6-digit department code number.  
**Product ID** = leave blank  
**Initiative** = 00+PI's 5-digit GEMS ID number (e.g., 0012345)  
**Project ID** = leave blank  
**Activity ID** = Budget
3. Fill in Name of Principal Investigator and Department Sponsoring Agency – USF Research & Innovation.
4. Budget Period – THE DATES PROVIDED IN THE AWARD EMAIL.
5. Project Title – Enter PEG and the title from the proposal.
6. Salaries & Fringe – Enter from Proposal Budget (if applicable)
7. Expenses – From your approved budget enter applicable expenses in the “Expense Item Category” and the subtotals in the “\$ Sponsor” column (refer to your approved proposal budget). If the expense item to be acquired is not an option in the drop-down list, you can type free text in the white cells. For this type of grant you do not need to fill in the “Budget Level Account” for these items.
8. Equipment – Enter if in approved budget, otherwise leave blank
9. Total Direct Costs – Add all subtotals from “\$ Sponsor” column.
10. Facilities & Administrative (F&A) Rate – There are no F&A (indirect) costs on a PEG internal award. Indirect costs = 0 %.
11. Total Project Costs – Added for you in the “\$ Sponsor” column. Remember: The “Total Project Costs” line may not exceed your award amount.
12. Signatures – The awardee must sign above “Principal Investigator,” and enter the date.
13. The Dean’s signature is not required on this type of grant unless it is a requirement of the department.

## **BUDGET CHANGE, EXTENSION, AND FINAL REPORT FORMS**

### **(1) Re-budgeting Request**

ANY re-budgeting must be requested and approved. Any unallowable expenditure/s on the award will be subject to removal off the grant to an unrestricted account. ### **(2) Requesting a One-Time Extension**

## COMPLIANCE APPROVALS, IF APPLICABLE

### CONFLICTS OF INTEREST

A conflict of interest related to research may exist when you or your spouse, domestic partner, or dependent children ("family members") have a financial interest or business relationship in an entity that is related to a research project. These interests and relationships must be disclosed via eCOI (<https://arc.research.usf.edu/Prod>) and receive approval from the Conflict of Interest Program prior to commencing research.

### USE OF HUMAN SUBJECTS IN YOUR RESEARCH

Researchers proposing to use human subject participants in the course of their research study are required to submit an application to the Institutional Review Board (IRB) for review and approval before initiating each project. This requirement encompasses a variety of research activities that can range from the simple use of data and surveys or interview procedures to more complex and invasive protocols such as clinical trials and treatment interventions.

The IRB communicates its findings via an official letter to the Investigator. Funds cannot be released until a copy of the IRB letter of approval is received. Consult the [ARC Portal](#), for electronic IRB submission, on the [Research and Integrity and Compliance](#) website.

### USE OF PROTECTED HEALTH INFORMATION

Researchers proposing to use "protected health information" (any individually identifiable human health information, including demographic information and biological specimens) in the course of their project must review the Health Insurance Portability and Accountability Act (HIPAA) Compliance Program information. The purpose of the HIPAA Compliance Program is to ensure that research studies involving use, disclosure or collection of "protected health information" are conducted with utmost respect to the privacy and confidentiality rights of the study participants thereby preserving and maintaining the public trust in the institution. Towards this, the HIPAA Compliance Program offers [HIPAA EDUCATION](#) as one-on-one and classroom-based trainings, as well as an extensive library of information.

### USE OF LIVE VERTEBRATES IN YOUR RESEARCH

All vertebrate animal use, including field studies, conducted by USF faculty, students, or staff, or supported by USF funds, must first be proposed to and approved by the IACUC. **Prior to the initiation of that activity** and regardless of where it will be performed, the PI must complete and submit to the IACUC one of the following forms based on the nature of the project: *Application for the Use of Animals in Research*, *Application for the Study of Wild Animals in Natural Settings*, *Application to Establish a Mouse Colony*, *Application for Antisera Production* or *Application for Use of Animal Tissues*. Please consult the [IACUC homepage](#) for contacts or more detailed information. **Funds cannot be released until a copy of the IACUC approval letter is received.**

### BIOHAZARDS

If you will use toxic wastes, radioactive materials, recombinant DNA, pathogens, explosives, and/or known carcinogens in your project, an explanation must be included in the proposal, and written approval must be obtained from the Institutional Biosafety Committee prior to commencing the work. Funds cannot be released until a copy of the approval from the IBC is received. Please consult the [Biosafety page](#) for contacts or more detailed information.

### INTELLECTUAL PROPERTY

Any inventions or copyrights resulting from activities supported by this program must comply with the Statement of Policy & Procedures for [Inventions and Works](#).
