- 6. Projects Returning for Second Presentation or decision (5-minute max. presentation time)
 - a. Hablab Oyster Restoration discussion and decision
 - i. Council recommended this project to be directed to St. Pete SGEFC for consideration
 - ii. It was brought to the Council's attention that St. Pete has a statement in their SGEF charter that mentions supporting sustainability projects that also benefit the campus and community. The Tampa Council is considering adding a similar statement to our charter – still open for discussion in the future.
 - b. Atlas Phase 2 (Morgan Mathews)
 - i. SGEFC voted and approved funding Phase II (\$12,831)
- 7. New Projects (5-minute max. presentation time)
 - a. Bull Charger Project (Anton Shapelev)
 - i. This project is part of a larger proposal in conjunction with SG for placement of Charging stations throughout campus for scooters and bikes. Specifically, this is for development of an app that is used internally by USF students/faculty/staff to see where there are available stations for charging
 - ii. Many questions were raised including maintenance of this development, IT support, and inclusion of the larger SG proposal

 - b. Bike Safety Initiative (Officer Nicole Marchesano/Linsey Araya)
 - i. Was not able to make the meeting and will come in November
 - c. Bull's Nature Trail (Grace-Ann Aarons, Leila Sujarani)
 - i. Proposal was for a design of a nature trail from the Claw through the USF Conservation area to a connecting point with the Riverfront Park nature trails
 - ii. Many questions were asked, and this will be discussed in the next meeting
