Statewide General Education Project Update

Karla Davis-Salazar announced that all statewide Faculty Discipline Committees (Communication, Humanities, Mathematics, Natural Sciences, and Social Sciences) have submitted their recommended courses to the Steering Committee, and all has been summarized on the FLDOE website (<u>http://www.fldoe.org/articulation/hb7135gep.asp</u>). The timeline for review process was also revised to include additional time for faculty review. Karla asked the group to plan on considering the adjustment to the mandated first 15 hours and as well as the remaining 15 hour requirements during our upcoming meetings.

The initial *recommended* statewide general education course options awaiting review and final state approval and their respective Learning Outcomes are as follows:

*For the mathematics and natural science core course options, the following policy should apply:

If a student completes a course in a subject area for which one of the general education core course options in the same subject area is a prerequisite, that student should be considered to have completed the portion of the core in that subject area. In some instances there may be courses similar in content in the general education program that are at a more advanced level, but do not include a core course as a prerequisite, in these instances the more advanced, similar course will be considered to have completed the portion of the core in that subject area.

FKL Course Approval Banner Deadlines

Karla Davis-Salazar briefed the council on course proposal Banner deadlines. She explained that each course proposal must be submitted, approved, and entered into Banner and Search-a-Bull before pre-registration begins for the next semester in order for the course to count as FKL that next semester. For example, a new FKL course approved in November cannot be offered as FKL until Summer 2013 at the earliest, due to spring registration having begun already. No action by the GEC is needed; this was informational only.
