- Kevin Yee, new Director of the Academy for Teaching and Learning Excellence (ATLE), was introduced.

# **Old Business**

- Substantive Change to Proposal Questions for Capstone and Writing Intensive Courses: The
  GEC reviewed revised wording and additional questions in the Dimensions Document regarding
  Capstone (CPST), Writing Intensive (WRIN), and Capstone Learning Experience (CLEX) courses
  that had been approved at the Sept. 17<sup>th</sup> meeting and voted to add the same wording and
  questions to the Recertification Form. The additional questions ask for evidence and explanation
  of how CPST and CLEX courses provide culminating educational experiences and how WRIN
  courses incorporate process writing.
- State Changes to General Education (HB 7135) Implications for Recertification: Chair Davis-Salazar reported that a letter was sent on Oct. 1 to departments with pending recertification proposals notifying them of the option to proceed with recertification this semester or to wait until the end of spring 2013 once the statewide general education committees have identified the 25 courses.
- Update on Statewide General Education Committees: The GEC chair announced the USF faculty nominated by the state General Education Steering Committee to serve on the statewide general education committees tasked with identifying 5 courses to be included in each of the 5 subject areas. The USF representatives are Bob Potter for natural sciences, Karla Davis-Salazar for social sciences, Marcus McWaters for mathematics, and Hunt Hawkins as alternate for communication. The state General Education Steering Committee did not select a USF faculty member for representation on the humanities committee.

#### **New Business**

Question regarding Credits Hours for CLEX Courses: The question of whether or not the CLEX experience was limited to only 6 credits was raised, as a department would like to propose a 10-credit hour internship experience as a CLEX. Associate Dean Moore explained that 6 of those 10 credits hours could count toward the CLEX, so proposing a 10-credit hour experience with 6 of those hours designated as fulfilling CLEX is not an issue.
