 - a) Elementary Education Limited Access proposal Diane Yendol-Hoppey from Elementary Education discussed a proposal to limit access to the undergraduate program. Under the current minimum entry requirements, the program still has too many students for its number of faculty. New entry requirements would eliminate part-time applicants and include 50 documented pre-professional hours, an ETS proficiency profile, and a proctored writing sample. It is expected that two cohorts of 35 students will be admitted annually under the new requirements. The proposal was approved.
